The Office of the New York State Attorney General's (OAG) <u>Medicaid Fraud Control Unit</u> (MFCU) seeks forensic accountant/auditors (FAA) for its Civil Enforcement Division in Latham, Pearl River and New York City. FAAs support the Unit by working in partnership with its attorneys, detectives, data analysts, nurses and legal support analysts to conduct complex, long-term healthcare fraud investigations.

The Medicaid program provides health coverage to millions of New Yorkers, including low-income persons, children, elderly adults and people with developmental disabilities. MFCU is the nation's premier law enforcement agency charged with ensuring the financial integrity of New York State's \$100 billion Medicaid program by investigating healthcare providers, such as pharmaceutical companies, doctors, hospitals, and nursing homes, who engage in Medicaid billing schemes that cause harm to Medicaid recipients and the loss of millions of dollars to the State of New York. MFCU also works to protect elderly and disabled New Yorkers by investigating reports of abuse and neglect in nursing homes and other residential health care facilities in the state.

Possessing both civil and criminal enforcement powers, MFCU uses various state laws to bring civil actions and criminal proceedings, including asset forfeiture actions. Many of the Unit's investigations are conducted in coordination with other federal, state, or local government and prosecutorial agencies, and have resulted in large-scale criminal convictions and the recovery of millions of dollars of taxpayer money.

Several recent matters that highlight MFCU's important work include the <u>OAG's report</u> concerning neglect of nursing home residents across New York State during the COVID-19 pandemic, and the recent filing of four major lawsuits against nursing homes, including <u>Centers Health Care</u>, <u>Cold Spring Hills Center for Nursing and Rehabilitation</u>, <u>The Villages of Orleans Health and Rehabilitation Center</u> and <u>Fulton Commons Care Center</u>, Inc.

Additional significant cases include recoveries of \$26.8 Million from drug manufacturer Mallinckrodt, <u>nearly \$7 Million</u> <u>from home health agencies for cheating workers and Medicaid fraud</u> and <u>\$22.7 Million from a pharmaceutical company</u> <u>for its kickback scheme.</u>

Candidates for the FAA position must possess the following qualifications:

- A minimum of a four-year college degree, either specifically in accounting, finance, economics, computer science with data analysis, applied statistics or equivalent post-college work experience.
- Excellent analytical, communication and organizational skills.
- The ability to function as an integral part of an investigative team and work in a group setting.
- Knowledge of fundamental computer applications, such as Word, Excel and Access.
- Proficiency with presentation software, such as PowerPoint.

Preferred skills for the FAA position are as follows:

- The ability to review financial records and advise or assist in the investigation of alleged fraud.
- Designation as a Certified Fraud Examiner.
- Experience with statistical sampling and/or advanced statistical training.
- Knowledge of the healthcare industry and medical coding concepts (CPT, ICD-9 / 10, DRGs) and/or

experience analyzing health care claims data.

• A CPA is not required; but the position qualifies for CPA accreditation purposes.

The annual salary for this position is \$65,014 + \$3,087 in location pay (NYC and Pearl River locations only). As an employee of the OAG, you will join a team of dedicated individuals who work to serve the people of our State through a wide variety of occupations. We offer a comprehensive New York State benefits package, including paid leave, health, dental, vision and retirement benefits, and family-friendly policies. Additionally, the OAG offers a robust Workplace Flexibilities Program with multiple options for employees, including telecommuting (up to two days per week) and alternative work schedules.

 - Your sample should demonstrate your ability to analyze and organize information to create an effective document that is well-organized and error-free.
 - If needed, please include a cover page to provide the reviewer with any relevant context or background information.
- List of three (3) references
 - Only submit professional references, supervisory references are preferred.
 - Indicate the nature and duration of your relationship to each reference.
 - Include contact information and email addresses for each reference.
 - Please note, your references will not be contacted until after you interview for the position.
